### **PRODUCT WARRANTY**

The parts submit, at their choice, for the resolution of conflicts and renouncing any other jurisdiction, to an arbitration tribunal or whoever takes their place, based in the city of **Barcelona**, **Spain**.

The declaration of nullity of one or more of the established non-essential purchase conditions will not lead to the nullity of the purchase agreement reached, which will continue in force.
