In this sense we inform you:

**1. Information of the person responsible for collecting the Data: WINGS MOBILE SPAIN, S.L.U., hereinafter WINGS MOBILE.**

**2. Purpose of data processing: WINGS MOBILE** collects, receives, uses and shares identifiable information for the development of its operations and, in particular, identifiable information from you for the purpose of communicating information about Wings Mobile products through our **INDEPENDENT AFFILIATES** or our websites, email, call centers, postal mail and other channels.

You expressly authorize that your data be transmitted, transferred and / or shared to subsidiary companies, subordinates or the parent company, as well as to third-part providers related to Data Processing (processing, handling, administration and / or analysis), even to countries that do not have implemented or issued data protection laws equivalent to the laws of Spain. Likewise, it authorizes such information to be verified and reviewed in different databases and / or lists of denied parts.

**WINGS MOBILE** undertakes to process the data under strict confidentiality and in accordance with high security standards. In this sense, it will not carry out sales operations on the data for which it grants this authorization.

In the exercise of your rights as holder of the Data, or when submitting a query or complaint, you must attach the following information:

- Name, address, email, telephone or any other means that allows us to contact you.

- Identification (where appropriate, document that proves the representation of the owner of the personal data).
- Accurate description of the type of action you want to be taken regarding your Data.
- Attach the documentation that supports the petition.

4. In the event that you decide to provide your data through any written or virtual means, they will only be used for the aforementioned purposes.
